- INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.
- Although not required, applicants are encouraged to submit recommendation letters and/or resumes to substantiate their application.

How to Apply:

Via email, you will be required to submit the following:

- Your personal information, including name and contact information.
- A 450+ word essay about what “justice in our society” means to you and how you have or will work to provide peace and justice for all members of our society.
- A digital copy of your school transcript.
- Recommendation letter and/or resume. (Optional)

By completing and submitting the required information below, you are verifying that you are eligible under all the criteria stated above, that you have been

accepted and plan to attend an accredited college/university during the 2019-2020 school year, and that you give HBO Law Firm permission to put your name on our website if you are awarded a scholarship. You are also giving HBO Law Firm permission to review your academic records. We will not share your information with anyone outside of the scholarship committee and will protect your privacy. The deadline to apply is May 31, 2019. The scholarship recipient will be notified by email on or before August 1, 2019.
