



RLHS Parking Rules/Regulations:

1. There will be no parking permits issued this year, but you must complete and submit the information below to park in the lot. Parking is based on a first come-first served basis in the student parking lots. Students who are not able to find a parking spot will need to park on Carson St. and Augusta St., as in past years.
2. The parking lot will be monitored by school personnel and the Student Resource Officer.
3. Only over the road, licensed vehicles are allowed to park on school grounds
4. Vehicles must be parked in the designated student parking areas so that they do not interfere with normal traffic routes.
5. Students are expected to operate their vehicles in a reasonable, prudent, and lawful manner. Students who park improperly or who drive in a reckless or imprudent manner will face disciplinary action that could include, but is not limited to, detention, loss of parking privileges, parking citations, or having their vehicle towed at the owner's expense.
6. No vehicle is to leave the school grounds during the school hours without permission from the school office with the exception of students regularly scheduled lunch period and students leaving for Early College Credit or Start College Now classes.
7. No vehicle is to have any occupancy during the school day, with lunch being the exception. The driver of the vehicle is responsible for this. All vehicles should be locked.
8. There are several spaces in the parking lots for handicapped parking. Any student who feels qualified to park in these areas should obtain a permit from the Department of Motor Vehicles.
9. In addition to the rules listed above, students are not permitted to park in areas designated for employee and/or visitor parking. Student parking areas are in the south parking lot and weightroom/tennis court lot. Students are not to park in the west lot or the northwest lot as those are staff and visitor parking areas.
10. All vehicles parked in the school parking lot are subject to searches by school personnel.

If you plan on utilizing the school parking lots, you must complete and submit the proper electronic form through your parent/guardian Family Access account

Choose one of 2 options for filling out the electronic form:
 - Option 1: Through the Back to School Forms and Fees process (it is one of the steps)
 - Option 2: Choose Online Forms (left side menu) and complete/submit the form
- You will be asked to submit the following for the Primary Vehicle that will use the lot and to agree (parent/guardian and student) to the statement below:
 - Vehicle License Plate #, Make/Model, Year, Color
 - I agree to follow the parking rules/regulations as listed on this form. I understand that use of the high school parking lot is a privilege and not a right. Further, I understand and will accept the consequences for improper parking, taking full responsibility for my actions as they pertain to the use of the high school parking lot.
